Incident Narrative

On June 24, 2010 the Washington Township Special Investigations Unit executed a court approved search warrant at the Super Accupressure Therapy located at 860 Rt. 168, Turnersville, NJ 08012. After a long term investigation it was determined that prostitution was taking place within the spa. As a result of the investigation the search warrant was executed and several employees were arrested on numerous charges. The below listed suspects were charged, processed and all lodged in the Gloucester County Jail after failing to post \$30,000.00 ten percent bail. The Washington Township Zoning Department also responded and found several violations. At this time the investigation is on-going and additional suspects may be charged.
