### Incident Narrative

On Wednesday, December 23, 2009 at approximately 1048 hours, a motor vehicle crash occurred on Fries Mill Road (County Highway # 655) between Georgetown Road and University Drive. A 2004 Hyundai Elantra was traveling southbound on Fries Mill Road when it contacted the rear of a 2001 Lincoln LS which was stopped within the southbound travel lane awaiting to turn left into a car wash. The Lincoln LS was then forced into the northbound travel lane where the front end of the Lincoln LS contacted the front end of a Ford Mustang traveling northbound within the northbound travel lane of Fries Mill Road.

The operator of the Hyundai Elantra was later taken, via personal vehicle, to Kennedy Hospital of Washington Township for evaluation. The operator and three passengers of the Lincoln LS were transported, via ambulance, to Kennedy Hospital of Washington Township for evaluation. The operator of the Ford Mustang was transported, via ambulance, to Kennedy Hospital of Washington Township for evaluation. All operators and passengers were wearing their seatbelts at the time of the crash.

A motor vehicle summons, for Careless Driving, was issued to the operator of the Hyundai Elantra.
