Incident Narrative

On Thursday, May 12, 2011, at approximately 2028 hours, a serious motor vehicle crash occurred on the Black Horse Pike (State Highway 42) southbound at intersection with Ardmore Avenue. A 1996 Chrysler was traveling to the west, from the northbound turn lane of the Black Horse Pike, in attempt to turn onto Ardmore Avenue. A 1998 Suzuki Motorcycle was traveling south, within the outside southbound travel lane of the Black Horse Pike, approaching the intersection of Ardmore Avenue. The front passenger-side corner of the Chrysler and the front of the motorcycle made contact within the outside southbound travel lane of the Black Horse Pike at intersection with Ardmore Avenue. The operator of the motorcycle also contacted the Chrysler before getting thrown onto the roadway.

The operator, of the Chrysler, was wearing her seatbelt and was uninjured. The operator of the motorcycle was wearing a full-face motorcycle helmet, leather motorcycle jacket and gloves. The operator of the motorcycle sustained a laceration to his forehead as well as fractures to his spine and was transported, via ambulance, to Cooper Trauma Center of Camden, New Jersey. The motorcycle operator is currently listed in stable condition.

Charges are currently pending further investigation.
