Incident Narrative

On January 20, 2011 at approximately 0110 hours the Washington Twp. Police Department received a call from a female victim reporting that she was just carjacked on S.H. 42 Southbound, Turnersville, New Jersey in front of the TGI Friday's Restaurant. The victim advised that she stopped at a traffic control device and that while stopped a male subject got in front of her vehicle and refused to move. The subject then raised his arm which was covered with a sock or sleeve and told her that he had a gun. The subject then ordered the victim to get out of the vehicle and to leave her handbag inside. The subject then entered her 2006 Toyota Solara and fled. Officers arrived on scene and were assisted by several off-duty Gloucester Township Police Officers who were in the area at the time of this incident. One of the off-duty officers spotted the stolen vehicle on S.H. 42, heading northbound and Sgt. Vince Lamonica attempted to stop the stolen vehicle. The suspect refused to stop for Sgt. Lamonica and a vehicle pursuit was initiated on S.H. 42 northbound and continued northbound. The suspect then attempted to exit S.H. 42 at exit 9A in Gloucester Township with the stolen vehicle but failed to negotiate the turn and crashed. The suspect was then taken into custody and arrested. He was charged with the robbery/carjacking of the vehicle, eluding, and possession of a controlled dangerous substance and his bail was set at \$200,000.00 full cash bail. He was taken to Kennedy Hospital in Washington Township for minor injuries sustained in the crash and then committed to the Gloucester County Jail in default of bail. The victim was not injured in the incident. Additional charges are expected.
