Incident Narrative

On May 26, 2011 at approximately 2:23 A.M., hours, the Washington Township Police department received a report of a stolen vehicle from a residence located on Wedgewood Dr, Turnersville, New Jersey. The 2005 Ford F-150 pickup truck was entered into NCIC and a report filed. At 3:57 A.M., Ofc. Anthony Aquilino spotted the vehicle being operated by a subject and attempted to stop the vehicle in the area of Hurffville-Crosskeys Rd., and the Crosskeys By Pass. The driver of the vehicle refused to stop and Ofc. Aquilino initiated a pursuit. Ofc. Aquilino pursued the vehicle and then lost sight of the vehicle in a residential development.

A few minutes later the vehicle was located again on Ganttown Rd., by Ofc. Sean Jackson and pursued again. A few minutes later the vehicle was involved in a crash after failing to negotiate a turn on Barclay Dr., Turnersville, N.J. The vehicle struck a curb and guide wire to a telephone pole and overturned. The suspect was then taken into custody at the scene and no officers were injured. The suspect who was identified as a 16 year old male was taken to Kennedy Memorial Hospital in Washington Township for minor injuries from the crash. He was then lodged in the Juvenile Facility in Lakeland and charged with Theft, Receiving Stolen Property, Eluding, Possession of a Controlled Dangerous Substance, Possession of Burglary Tools, and Possession of an Unlawful Weapon. Officers at the scene also recovered items from the suspect which are believed to be stolen property from other vehicles in the area of Wedgewood Dr. This investigation is on-going and officers are attempting to identify the owners of the recovered property. Additional charges are expected as the property owners are identified.
