### Incident Narrative

On 01/14/10 at 7:10 PM a motor vehicle crash occurred in Washington Township On Glassboro Cross-Keys Road between Oak Ridge Lane and Jenna Way. A 1990 Nissan 240 SX and a 1996 Jeep Cherokee were traveling on Glassboro Cross-Keys Road. Both vehicles collided and the Jeep overturned. The driver of the Nissan was pronounced deceased at the scene. The lone passenger of the Nissan was trapped and had to be extricated from the vehicle by fire department personnel. The passenger of the Nissan and the driver of the Jeep sustained injuries and were transported to Cooper Trauma Center via Washington Township Ambulances.

Glassboro Cross-Keys Road between Fries Mill Road and Hurffville Cross-Keys Road was closed for approximately 3 ½ hours.

The two occupants of the Nissan and the single occupant of the Jeep were wearing seatbelts. The cause of the crash is under investigation and no charges have been filed at this time.
