### Incident Narrative

On April 21, 2009 at approximately 1952 hrs., a taxi-cab was reported stolen from the area of the hospital. Sergeant Dennis Sims was on patrol near the area and observed the described vehicle being operated on Hurfville Cross Keys Rd. in Washington Township. It was later discovered that the vehicle was being operated by the subject listed below. Sergeant Sims attempted to stop the stolen vehicle, however, the operator of the vehicle refused to stop and a vehicle pursuit developed. The pursuit continued into Glassboro, where the Washington Township Police were assisted by Glassboro PD and other departments listed above. The subject struck a house and several trees in Glassboro, but continued to flee. The pursuit ended when the subject exited the stolen vehicle and fled on foot in Elk Township. The subject was eventually apprehended after continuing to try to flee from and fight with officers. The apprehension was made with the assistance of two K-9 units, one from Glassboro and one from Washington Township Police Department. The subject was not injured during the incident. No police vehicles were damaged. Four officers suffered minor injuries while attempting to overcome the resistance from the subject during the apprehension. The subject was taken to JFK Hospital, Washington Township Division, for an evaluation. He was charged, both in Washington Township and Glassboro, with numerous offences, the most serious listed below. At this time he remains in custody in default of bail.
